Invitation for Bids

1. The Province Government, Province No. 3 has allocated the funds to cover eligible payments under the Contract for *Upgrading of Mude Baghkhori Kalapani Road (CH 0+000 to 16+500 Km)*(Contract No. *IDOSIN/W/NCB/09/075-76*). Infrastructure Development Office, Sindhupalchok invites sealed bids from all eligible registered Nepalese contractors for submission of their bids electronically. Bidding is open to all eligible as per Section V of bidding document.
2. Infrastructure Development Office, Sindhupalchok invites electronic bids under NCB-Single stage Two Envelope Bidding Procedure.
Only eligible Bidders with the following key qualifications should participate in this bidding:
 - a) Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 316 million.**
 - b) Minimum Work experience of similar size and nature works: At least **2 (Two) Contracts** of Road upgrading or construction within the last ten (10) years, each with a value of at least amount **NRs. 337 million** that have been successfully or are substantially completed.
3. Eligible Bidders may obtain further information at Infrastructure Development Office (IDO), Sindhupalchok or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
4. Bidder should submit their bid electronically and may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidder should deposit **NRs. 20000.00** as the cost of bidding document in the Office Rajaswa (revenue) account as specified below.

5. Pre-bid meeting shall be held at **Infrastructure Development Office, Chautara Sangachokgadhi Municipality-8, Sindhupalchok**, on **2075/12/24 (7th April, 2019)** at **12:00 hrs.**
6. Electronic bids must be submitted to the Infrastructure Development Office, Sindhupalchok through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hrs** on **2076/01/03 (16th April, 2019)**.
7. The Technical bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hrs** on **2076/01/03 (16th April, 2019)** at **Infrastructure Development Office, Chautara Sangachokgadhi Municipality-8, Sindhupalchok**. Each Bid must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format having minimum amount of **NRs. 10 million Rupees only**, which shall be valid for **30 days** beyond the validity period of the bid.
8. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
